



# How we can help you manage information safely

## Support for NHS organisations including clinical commissioning groups and primary care

- We ensure customers are compliant with all IG requirements and guidance, including:
  - The Data Protection Act, incorporating the General Data Protection Regulation (GDPR)
  - National mandated best practice including the Data Security & Protection Toolkit, Caldicott Principles and Information Standard ISO27001.
- Onsite delivery is supported by a remote service, the IG Hub. Via a helpdesk facility, the hub provides specialist advice and support to our customers Monday to Friday 9am - 5pm. In addition, we also provide a full Access to Information service, responding to over 1,000 information requests per year on behalf of our customers.
- We provide a named Data Protection Officer (DPO) who is supported by senior Information Governance (IG) team members to deliver the DPO requirement and manage queries that are particularly complex or confidential. Delivering the service in this way ensures appropriate cover is in place at all times to deal with time sensitive issues such as breach reporting.
- We train and assess a large number of people in information governance each year - some 1,600 in-house, and a further 1,600 within the customers we serve.

## Additional support for general practices, pharmacy, dental practices and optometrists

- MLCSU has a primary care portal with a designated IG area enabling customer practices to access personalised template documentation, policies and procedures that meet the Data Security and Protection Toolkit requirements.
- We provide central training workshops for primary care IG leads, Caldicott Guardians and practice managers.

- MLCSU is supporting care homes to become Data Security and Protection Toolkit compliant, allowing them to access NHS.net services and in turn, access electronic integrated care systems. In 12 months (from July 2019) the service has supported over 100 care homes across three separate localities.
